

<u>The Will County Waste Hauler Reporting Ordinance</u> pursuant to the Illinois Solid Waste Planning and Recycling Act (415 ILCS15/1 et seq), according to the Attorney General of Illinois, counties may require waste haulers to report the amounts of waste generated and recycled for compliance purposes pursuant to the Illinois Solid Waste Planning and Recycling act. Will County Land Use Department, Resource Recovery and Energy Division ask you to report the amount of landscape waste hauled from Will County jobsites (located in both municipalities and townships) during the previous six-month period. Base reports on tipping fees and include landfill location. Those not operating in Will County or those who intend to report "zero" under totals, please have owner/manager include a signed addendum to that affect. It shall be a petty offense to violate this ordinance; violators may be subject to a fine not to exceed \$500 per offense. This report is due 30 days after each six-month reporting period ends.
